Rules Committee: Dave now has the master copy of the new and updated rules handbook in a pdf formate. He will be forwarding on to the board members for review shortly.

A & E Committee:

Architectural - Outlot 2D and 3 improvement bid has been completed, and still needs to be paid.

Environmental - According to Joe Stangl, the rain has caused so much water turnover in the lake that it is going to be hard to get an accurate reading for the water status. The fish status is excellent and many have seen and caught different types of good size fish.

Maintenance- Steve and Mary Hermansky should know more about the status of the slopes in August. The steps are in, but not the dock for lots 184,185 and 187. The A&E committee has not made a decision as to which contractor they will be using for the seawall repair. Dave mentioned about doing a homeowner waiver. If the contractor were to damage any sprinkler heads/etc, there should be a waiver of liability.
